The Board in its Notification cited under reference (1) above had called for applications through online for the Recruitment for 31 posts of First Division Accounts Assistants along with 100 posts of Assistant Engineers. Candidates at the ratio of 1:3 were called for verification of original documents vide reference (2), Subsequently the Provisional Selection List was published on 11.8.2016 inviting objections if any from the aggrieved candidates. After giving due consideration to the objections, the Final Selection Lists for 79 Posts of Assistant Engineers (70 Posts under Residual cadre and 9 Posts under Local cadre) and 27 Posts of First Division Accounts Assistants are published on 07/11/2016. 4 Posts of First Division Accounts Assistants under Local cadre was not published due to non availability of qualified candidates. After due verification of original documents on 16/08/2016, 08/09/2016 and 30/12/2016, the Provisional Selection List for 4 Posts of First Division Accounts Assistants under local cadre is published for the information of the concerned.

Objections received after the said date will not be considered.
